The highlights of the meeting follow:

- Vice President's report
 - ➤ John once again reviewed plans for upcoming presentations which include:
 - April: Propagation- Buddy Morgan
 - May: Parks On The Air- Justin Sligh (tenative)
 - June: Satellite Communications Andrew Glasbrenner
- Secretary's report
 - ➤ Bill read the minutes from the last board meeting.
 - ➤ The club equipment inventory is almost complete. Last minute changes have delayed finalization.
- Treasurer's report
 - ➤ Todd gave his Treasurer's report, and it was approved as read.
 - Matthew informed the group that the cost of printing the club's tri-fold brochure was \$0.60 per copy in quantities of three-hundred.
- Dave Lafave was reinstated as a board member, filling the vacancy left by Eleanor Marshall.
- The board voted to purchase a canopy for events like the First Friday. Jim Stewart will purchase the canopy, and Todd Rush will purchase the rope lights as accessories. Bill will store both at his house.
- Mike Shreve has taken on the task of sending radiograms to new hams who test with us. He
 also mentioned that the new system for obtaining badges is working well.
- In order to change the date of the meeting from the first Monday to the second Monday of the month, the bylaws need to be amended. This in noway impacts our charter, and is considered a minor change. The board voted in favor of the change from first to second Monday. A vote will be put to the members attending the next general special meeting the second Monday in April. It is expected to pass.
- There are parts of the bylaws pertaining to elections that some members feel should be changed. Our bylaws were written in the seventies, before email, the Internet, and the World Wide Web. - Mike Shreve mentioned that having the personal information of those we test would help him promote the club to new hams. Rich agreed to share that information with Mike.
- Dave LaFave will work with Todd Rush, Jim Stewart, Bill Paul, Top Smith, and team leader Bill Johnson on the remaining first Friday events.
 - There was a short discussion pertaining to what we could do better next time. Bill pointed out that some of the members had suggested a change in signage placement. Bill and Jim will pursue this. Tod suggested some kind of visual at the booth to get people involved, for example a video. Todd will share his thoughts with the other members of the team to see how we might implement his idea.
